This Indenture made the day of 1885 Between Samuel Ward of Hartwith near Ripley in the County or York, Farmer of the 1<sup>st</sup> part The Most Honourable George Frederick Samuel Marquess of Ripon K. G. and the Right Honourable Frederick Oliver Earl deGrey of the 2<sup>nd</sup> part and the Right Honourable Beilby Baron Wenlock of Escrick Hall in the County of York and Reginald Barliol Brett No 6 Enismore Gardens South Kensington in the County of Middlesex Esquire of the 3<sup>rd</sup> part Whereas Richard Weatherhead late of Summer Bridge in the County of York Farmer being at the date of his Will and at the time of his death hereinafter respectively mentioned seized in fee simple of the hereditaments hereinafter expressed to be hereby granted by his Will dated 17<sup>th</sup> day of August 1877 appointed his wife Hannah Weatherhead and Joseph Kirkley of North Pasture near Sawley in the County of York Farmer and the said Samuel Ward to be the Trustees and Executors thereof and after bequeathing his Household Furniture and other personal chattels and a legacy of £20 to his said Wife he bequeathed to her an Annuity of £100 during her life and he also

bequeathed to Ann Batty (the daughter of Eliza Pearson) a Legacy of £300 free from Legacy duty payable 6 months after his decease and he bequeathed to the said Eliza Pearson an Annuity of £40 during the life of the Testators Wife And the said Testator gave devised and bequeathed to his said Wife and the said Joseph Kirkley and Samuel Ward (who and the Survivors and Survivor of them and other the Trustees and Trustee for the time being of that his Will were and was thereinafter referred to as his said Trustees) All his messuages lands tenements hereditaments and premises wheresoever situate and whatever tenure the same might be along with the residue of his personal estate Upon trust for sale and conversion and investment of the proceeds of his personal estate as therein mentioned and after answering the annuities and legacies thereinbefore bequeathed and paying all the costs of keeping his real and leasehold estates in good repair to accumulate as therein mentioned the rents and interest of his Residuary Real and personal estates during the life of his said Wife And from and after her decease Upon trust to sell all his Real and Leasehold estates together or in parcels by public auction or private contract with power to make any special conditions as to title or evidence of title or otherwise and with power to buy in the premises at any public sale or to rescind either or terms or gratuitously and contract and to resell without being

answerable for any consequent loss and to convey and assure the premises are sold to the Purchaser or respective Purchasers thereof and to give all necessary receipts relating thereto And the said Testator empowered his said Trustees to give receipts for all monies and effects to be paid or delivered to them by virtue of his Will And he declared such receipts should exonerate the persons taking the same from all liability to see to the application or disposition of the money or effects therein mentioned And whereas the said Testator died on the 7th day of December 1877 without having altered or revoked his said Will which was on the 25<sup>th</sup> day of March 1878 duly proved by the said Samuel Ward alone in the Principal Registry of the Probate Division of the High Court of Justice And whereas the said Joseph Kirkley died in the lifetime of the said Testator namely in the month of October 1877 and was interred at Middlesmoor in the County of York And whereas the said Hannah Weatherhead the Widow of the Testator died on the 12<sup>th</sup> day of February 1885 and was interred at Dacre Banks in the said County of York and her Annuity was duly paid up to the day of her decease And whereas the said Samuel Ward has agreed with the said Marguess of Ripon and Earl deGrey for the absolute sale to them of the hereditaments hereinafter described and the inheritance thereof in fee simple

in possession free from incumbrances for the sum of £2200 And whereas by an Indenture of Settlement dated the 31st day of July 1877 and made between the said Marquess of the 1st part and the said Earl the 2nd part The most Honourable Henrietta Anne Theodosia Marchioness of Ripon (the wife of the said Marguess) of the 3<sup>rd</sup> part and the said Baron Wenlock (then the Honourable Beilby Lawley) and Reginald Baliol Brett of the 4<sup>th</sup> part certain Manors Messuages lands and hereditaments in the Counties of York and Lincoln therein particularly described in the 1<sup>st</sup> and 2<sup>nd</sup> Schedules thereof were assured and limited unto the said Beilby Lawley and Reginald B Brett and their heirs To the uses and upon and for the trusts intents and purposes and with under and subject to the powers provisoes agreements and declarations therein limited and contained concerning the same respectively And whereas the said Marquess as tenant for life in the possession of the said settled Manors and hereditaments And also the said Earl as tenant in tail? in remainder are desirous and have requested that the said hereditaments hereinafter described and granted should be granted and conveyed To the uses and in manner hereinafter mentioned Now this Indenture Witnesseth that in pursuance of the said recited contract and agreement And in consideration of the sum of £2200 sterling paid by the said Marquess and the said Earl to the said Samuel Ward (The receipt whereof the said

Samuel Ward doth hereby acknowledge) He the said Samuel Ward, as Trustee, and at the request of the said Marquess and the said Earl, testified by their respectively executing these presents doth hereby grant and convey unto the said Baron Wenlock and Reginald Baliol Brett and their heirs All that messuage tenement or dwellinghouse with the Barns Stables and other outbuildings thereto belonging And also all those several closes or parcels of Arable meadow and pasture land heretofore commonly called or known by the several names Holme Close, Little Close, Middle close, High close, Rape close, Near Allotment, Middle Allotment, Far Allotment, High Field, High Pasture, Calf Garth, Middle Field, Lady Hill, Low Pasture, Low Stand, Low Bottom, The Hill and Little close and stated to contain together by admeasurement 19a Or 13p but recently found to contain 82a Or 36p bounded on the East by lands formerly of John Bacon Sawrey Morritt Esquire and now the said Marguess of Ripon on the West by Swetton Common, on the North by lands late of the said John Bacon Sawrey Morritt and now of the said Marquess of Ripon and on the South by lands of the said Marquess of Ripon All which said premises are situated in Dallowgill in the Parish of Kirkby Malzeard in the County of York and commonly called "Vicar Pasture" otherwise "Riddings" late in the occupation of Peter Burrill

and now by Messr's Whitwham and the same premises are now better known by the more modern description thereof set forth in the Plan and Particulars appearing at the end of these presents, the premises on the said Plan being edged round with a Green verge line To hold the same premises Unto the said Baron Wenlock and Reginald Baliol Brett and other heirs To such uses and Upon and for such Trusts and with under and subject to such powers provisoes agreements and declarations as were limited declared and contained or referred to in and by the hereinbefore recited Indenture of the 31<sup>st</sup> day of July 1877 of and concerning the hereditaments described in the 1<sup>st</sup> and 2<sup>nd</sup> Schedules to the same Indenture or such and so many of them as are still subsisting and capable of taking effect
