

Schedule of Deeds and writings relating to the title of a freehold Dwellinghouse and land situate at Skelding in the Parish of Ripon in the County of York belonging to Mr William Ingleby and in mortgage to Mr Henry Stephenson for securing £400 and interest at £4 %

- 11<sup>th</sup>, 12<sup>th</sup> May 1798 Indentures of Lease and Release both made between John Steward of the one part and William Ingleby and Dinah his wife of the other part
- 5<sup>th</sup> & 6<sup>th</sup> January 1810 Indentures of Lease and Release the latter made between Dinah Ingleby of the 1<sup>st</sup> part John Ingleby of the 2<sup>nd</sup> part and Robert Peart of the 3<sup>rd</sup> part
- 6<sup>th</sup>, 7<sup>th</sup>? June 1820 Extract from the Grantley and Skelding Inclosure Award as to Mr William Ingleby's property
- 22<sup>nd</sup>, 23<sup>rd</sup> April 1840 Indentures of Lease and Release the latter made by William Ingleby of the 1<sup>st</sup> part Susannah Ingleby of the 2<sup>nd</sup> part and Elizabeth Blackburn of the 3<sup>rd</sup> part
- 25<sup>th</sup> March 1850 Indenture made between Christopher Horn of the 1<sup>st</sup> part William Ingleby of the 2<sup>nd</sup> part Richard Ella Hutchinson, Thomas Carter and Benjamin Akers of the 3<sup>rd</sup> part
- 24<sup>th</sup> January 1884 Indenture (indorsed on the last mentioned Indenture) made between Thomas Carter of the one part and Joseph Akers, William Wintersgill, George Mallaby and George Furby the younger of the other part
- 23<sup>rd</sup> November 1885 Indenture made between William Ingleby of the 1st part Joseph Akers, William Wintersgill George Mallaby and George Furby the younger of the other part

I the above named and undersigned Henry Stephenson of Galphay in the Parish of Ripon in the County of York Gentleman do hereby acknowledge to have secured the several documents and writings comprised in the foregoing Schedule and I undertake to deliver the same to the above named William Ingleby of Skelding in the said Parish of Ripon farmer his executors administrators or assigns on payment to me my executors administrators or assigns of all moneys secured to me by the last mentioned Indenture and in the meantime to keep the same documents and writings safe whole uncancelled and undefaced (fire theft and inevitable accident only and always excepted) dated this 25<sup>th</sup> day of February 1886
