ASSENT

(3) The said Annie Elizabeth Pearson by her will date the Twenty first day of February One thousand nine hundred and thirty six after appointing the Executors Executors and Trustees thereof and making a certain devise and bequeath not affecting these presents gave devised and bequeathed the rest residue and remainder of her real and personal estate whatsoever and wheresoever (hereinafter called "the residuary estate") unto the Executors Upon Trust to sell the same and out of the proceeds thereof to pay her just debts funeral and testamentary expenses and certain legacies therein specified and to pay the balance remaining in their hands unto the said Thomas Kirkley absolutely. (4) The said Annie Elizabeth Pearson died on the Twenty third of February One thousand nine hundred and forty two and her said Will was proved by the Executors at the Principal Probate Registry at Llandudno on the first April One thousand nine hundred and forty two. (5) After the death of the said Annie Elizabeth Pearson it was ascertained that the said farm known as Hoggerston Hill had been conveyed to the said John William Pearson and Annie Elizabeth Pearson in fee simple as joint tenants, beneficially

hundred and forty two and made between the said Thomas Kirkley of the First part the said Frederic Stockton Gowland and William Watson of the second part and the Executors of the third part after stating that the parties thereto were of the opinion that both the said John William Pearson and Annie Elizabeth Pearson at the date of their respective Wills believed that the said farm known as Hoggerston Hill had been conveyed to the said John William Pearson alone that the devise thereof in his said Will expressed the wishes of both the said John William Pearson and Annie Elizabeth Pearson and the Executors had made other provisions for the payment of the debts funeral and testamentary expenses and legacies charged on the said residuary estate and had not assented to themselves as trustees for the sale it was declared that the said Thomas Kirkley should not make any claim to the said farm as being part of the said residuary estate of the said A. E. Pearson and that he authorized the Executors to make such assent in respect of the said farm as might be necessary or expedient for carrying out the devise thereof contained in the said Will of the said John William deceased. -NOW the Executors as Personal Representatives of the said Annie Elizabeth Pearson hereby:-1. Assent to the vesting in the said Harriet Barker of All and Singular the freehold messuage and property described in the Schedule hereto for an estate in fee simple. 2. Acknowledge the right of the said Harriet Barker to production of the Probate of the said Will of the said Annie Elizabeth Pearson and to delivery of copies thereof. -3. Declare that they have not previously given or made any assent or conveyance in respect of any legal estate in the premises the subject of this Assent. AS WITNESS the hands of the parties hereto. -
