property hereby conveyed **Now** in pursuance of the said agreement and in consideration of the sum of Eight hundred pounds now paid by the Purchasers to the Vendors out of monies belonging to them on a joint account (the receipt whereby the Vendors hereby acknowledge)

This Conveyance Witnesseth as follows:-

- 1. The Vendors as Personal Representatives of the said John Tennant deceased hereby convey unto the Purchasers All that messuage dwellinghouse or farmhouse together with the two closes or parcels of land commonly known as Hoggerston Hill situate in the Township of Laverton in the County of York and containing in the whole eighteen acres or thereabouts and now in the occupation of Fred Peacock as Tenant thereof All which said premises are more particularly described in the Schedule hereto To hold the same unto the Purchasers as joint tenants in fee simple
- 2. The Purchasers shall stand possessed of the property hereby assured upon trust to sell the same with power at discretion to postpone any such sale and shall stand possessed of the net proceeds of sale (after payment of expenses) and of the net rents and profits until sale (after payment of rates taxes costs of insurance repairs and outgoings) In trust for the Purchasers as joint tenants beneficially
